**Paid/Non-Fee Waiver:** Payment must be made strictly through the College Portal.

**Fee Waiver Candidates:** The fee structure and eligibility will be strictly as per the latest Government of Assam Official Order after verification of documents by College Authority.

#### IMPORTANT INSTRUCTIONS FOR FEE WAIVER

The Fee Waiver facility is strictly subject to the latest Government of Assam norms. To qualify, students must meet the following criteria: *(Aadhar Card's Information should be matched with University's Information to be eligible for Fee Waiver)*

- **Parental Income:** Below Rs. 4.00 lakh/year from all sources.
- **Attendance:** Minimum 70% in the previous academic year.
- **Academic Record:** No arrears, backlogs, or missed final exams in the previous year.
- **Conduct:** Waiver will be revoked for vandalism, ragging, misconduct, or anti-social activities.

#### DOCUMENTS REQUIRED FOR SUBMISSION

Candidates must submit copies of the following documents at the time of admission:

1. **Copy of Renewal Admission Application** (from College Portal)
2. **Copy of Student's Aadhaar Card:** Applicants must possess a valid Aadhaar number (matching student's name, gender & DOB with college & Aadhaar), and this information must be submitted along with a signed consent to the institution.
3. **Family Income Proof (Mandatory for Fee Waiver only):** An Income Certificate issued by the concerned Revenue Circle Officer shall be treated as the primary proof of income. If the Income Certificate is not available, only then will an AAY (Antyodaya Anna Yojana) or PHH (Priority Household) Ration Card, submitted in the proper format, be accepted.
4. **Copy of All Semester Mark Sheet.**
5. **Copy of Previous Class/ Year Admission Money Receipt.**
6. **Undertaking of Parental Employment Declaration Form (Non-Government Employee)**
